**SOCIAL MEMBERSHIP CONTRACT**  
*New Era Golf Ohio*

**Section 1. Application**

- A. General.** This membership Application and Agreement ("Application") is submitted by the undersigned ("Prospect") for the purpose of applying for Membership at New Albany Links Golf Club ("Club").
- B. Membership.** The Prospect applies for the following category of membership ("Membership") in the Club. These categories are described in the Membership Package:

- C. Membership Rules and Regulations.** The Prospect has received and read the Membership Agreement. The Prospect agrees fully to be bound by the terms and conditions thereof as changed from time to time. All rules and regulations are subject to amendment, modification, or supplement at the discretion of the Owners.
- D. No Ownership or Right to Participate in Management.** The Prospect acknowledges and agrees that Membership in the Club does not include: (i) any ownership or other proprietary interest in the club or any of its assets, (ii) any right to receive or participate in the earnings of the Club, or (iii) any voting rights or any right to participate in the management or operation of the Club.
- E. Indemnification: Assumption of Risk.** By executing the Application, The Prospect, upon becoming a Club Member, agrees to indemnify, defend and hold the Club (and its owners, officers, employees and other agents) harmless from and against any and all liabilities, costs (including reasonable attorneys' fees), claims, demands or damages incident to or arising out of the acts or omissions of the Prospect, his or her Family members or Guests, arising out of or relating to the use or occupancy of the Club Facilities. In additions, Prospect agrees to hold the Club (and its owners, officers, employees and other agents) harmless from any and all damage to the Prospect's person or property, and the person or property of the Prospect's Family and Guests arising out of or relating to the use or occupancy of the Club Facilities.

**Section 2. Agreement**

The execution of this Application constitutes and acceptance by the Prospect of the terms and conditions of Membership in the Club in accordance with the provisions of this Application.

The Membership will last for a minimum of 12 months from the date of purchase. The membership will automatically renew for an additional 12 months upon anniversary date unless the Member contacts the club in writing prior to anniversary date. All rates are subject to change, with a 90 day notice given. If a member breaks the clause of the contract, he/she will be responsible for the remaining months owed to the club to fulfill its agreement of 1 year or 12 months.

If the Members account should go past due more than 30 days the Club has the option to cease all Membership privileges and may suspend the Membership until the account is brought current. The Member agrees that the Club may assess a late charge of 1 ½% of the delinquent amount for past due accounts.

The Member agrees that the Member, Members family and guests will abide to the Policies and Procedures of the Club and any policies, procedures or regulations that may be posted from time to time.

If the Member is relocated due to work or other circumstances outside their control, the Member may request to be released from the Membership inside of the contract period provided the following criteria are met a) the Member is relocated outside of a 50 mile radius from the Club b) Member provides acceptable change of address and / or proof of new residency. Member may be responsible for the monthly dues through the term date of the contract. Management will review case by case.

As evidenced by my signature below, I attest that the information contained herein is accurate and correct, and I authorize New Era Golf Ohio and / or New Albany Links Golf Course to charge my credit card listed below on the first of every month during my Membership for all club charges. As a Member I can change the credit card I am authorizing at anytime, but must allow up to 30 days for the change. A valid credit card MUST be kept on file at all times.

**FEE:**  
Allows all members access to pool, tennis courts and work out room - also gives you 6 free golf rounds (excludes cart fee) and 10% off food and beverages at the Links Pub. Social members are required to spend \$60.00 per month on food and beverage. Minimums can be met at both the Pub and the Snack Shop at the pool. All dues are subject to 7.5% sales tax. All New Era Golf Memberships are entitled to half off the monthly dues.

**CLUB INITIATION FEE:** At time of enrollment, a one time enrollment fee of \$1,000 shall be applied. Upon resignation, Member shall receive \$500 of enrollment fee once membership space has been filled.
